

Penalties under Climate Law No. 7552

Article & Violation Type	Penalty Amount
14-(1)-a: Failure to submit the verified greenhouse gas emission report within the specified period	500,000 TL - 5,000,000 TL
14-(1)-b: Doubling of penalties specified in (a) for businesses under the ETS scope	1,000,000 TL - 10,000,000 TL
14-(2)-a: Using, importing, trading, or placing on the market substances that deplete the ozone layer	2,500,000 TL
14-(2)-b: Providing maintenance, repair, or service for products or equipment containing ozone-depleting substances	250,000 TL
14-(2)-c: Non-compliance with labeling requirements for products or equipment containing ozone-depleting substances	120,000 TL
14-(3)-a: Using, trading, or placing fluorinated greenhouse gases on the market	2,500,000 TL + Suspension of Hydrofluorocarbon Control Certificate for 3 to 6 months
14-(3)-b: Importing hydrofluorocarbons without quota or exceeding the quota	1,000,000 TL + Quota reduction equal to the excess amount
14-(3)-c: Non-compliance with labeling requirements for containers, products, or equipment containing fluorinated greenhouse gases	120,000 TL
14-(3)-ç: Failure to submit notifications or reports to the database on time, or failure to update the data	120,000 TL
14-(3)-d: Intervening with equipment containing or operating with fluorinated greenhouse gases	120,000 TL
14-(4)-a: Failure to submit the verified greenhouse gas emission report on time (restriction on transactions in registry accounts)	Administrative fine + Transaction restriction until report submission
14-(4)-b-1: Operating without permit for businesses with verified annual greenhouse gas emission report	5 TL per ton of CO ₂ equivalent emissions

14-(4)-b-2: Operating without permit for businesses without verified annual greenhouse gas emission report	1,000,000 TL - 10,000,000 TL
14-(4)-c: Failure to deliver the required amount of allowances within the period under the ETS	Administrative fine equivalent to 2 times the higher of primary or secondary market weighted average allowance price per undelivered allowance
14-(4)-ç: Failure to fulfill at least 80% of the annual allowance delivery obligation for three consecutive years under the ETS	Revocation of greenhouse gas emission permit + Suspension of new permit for 3 to 6 months
14-(5): Failure to fulfill the obligation specified in Article 11, paragraph 5	120,000 TL
14-(6): Failure to provide required information, documents, or data, or making misleading declarations	170,000 TL
14-(9) First Repeat: Repetition of an offense subject to administrative fine within 3 years	Fine amount increased by 1 time
14-(9) Second and Subsequent Repeats: Repetition of an offense more than once within 3 years	Fine amount increased by 2 times
14-(10): Granting time to correct non-compliance with the law or regulations	Partial or full suspension of operations until compliance is achieved
14-(11): Maximum administrative fine per offense	50,000,000 TL
